Hence, I request you to take this as a priority item and allot Government land an extent of minimum (15) acres on free of cost for newly sanctioned (02) TTW EMR School at Gudur and Kothaguda Mahaboobabad District at an early date and help us to serve the most marginalized and deserving population of your district with utmost empathy and efficiency.
