As per the guidelines of NESTS, MoTA, issued vide ref 1<sup>st</sup> & 2<sup>nd</sup> cited the entrance test for admission into 6<sup>th</sup> class for the academic year 2023-24 is conducted on 07.05.2023 and the results have been announced on 31.05.2023.

The institution wise allotted details for 1<sup>st</sup> phase list is enclosed in the annexure- I. The list of category wise allotment of the students is enclosed in the Annexure-II.

Therefore, all the principals are hereby instructed to admit the allotted students for 6<sup>th</sup> class from 01.06.2023 to 10.06.2023.

The following guidelines have to be followed strictly for admission procedure:

- 1. The principals have to collect the following common documents from all the selected students.
  - a. Rank card / Admission card
  - b. Transfer certificate
  - c. Bonafide/ Study certificate
  - d. Physical Fitness certificate from PHC
  - e. Income Certificate of present year

2. Mandatory documents:

# 3. The Principals are instructed to collect the mandatory certificates from the candidates at the time of admission only. No Principal should allot the seat by undertakings letters.

- 4. The 1<sup>st</sup> phase admissions should be completed on or before 10.06.2023. The detailed report along with vacancies should be reported to the Head Office, TSES on 11.06.2023.
- 5. All the documents should be verified by the principal and admission committee at school level thoroughly. If any lapses, the Head of the institution will be held responsible.
- The process of admission has to be taken place as per the norms & guidelines. If any deviation, disciplinary action will be initiated against the Head of the Institution.
