Dear Principal

The schools are therefore requested to undertake Cleanliness Drive – “**Ek Tareekh Ek Ghanta Ek Sath**” for atleast one hour on 01.10.2023 at 10:00 am resulting in visible cleanliness at the site chosen by the school.
